Justice Surya Kant	53rd Chief Justice of India (CJI)	Succeeds Justice Bhushan R. Gavai. Term runs until February 9, 2027. He is the First CJI from Haryana. Assumes charge on November 24, 2025. He was also appointed as the Executive Chair Person of the National Legal Services Authority in May 2025.
Vishvajit Sahay	Controller General of Defence Accounts (CGDA)	Assumed charge on November 1, 2025.
Shrish Chandra Murmu	New Deputy Governor of the Reserve Bank of India (RBI)	Appointment took place in October 2025.
Shailesh Chandra	President of the Organisation Internationale des Constructeurs d'Automobiles (OICA)	He is the First Indian President of OICA and succeeds John Bozzella.
