





# Industry, Labour & Macroeconomic Indicators

- MoSPI will release the All-India IIP on the 28 th of every month starting April 2025, cutting the publication lag to 28 days (from 42).
- 2. Current IIP base year: 2011-12; sectors covered: Mining, Manufacturing, Electricity.
- 3. Labour Force Participation Rate (15 + yrs) improved to 60.1 % in 2023-24 (from 49.8 % in 2017-18).
- 4. Women now hold 39.2 % of all Indian bank accounts and contribute 39.7 % of total deposits.
- 5. Female demat accounts rose from 6.67 mn (Mar 2021) to 27.71 mn (Nov 2024).
- 6. DPIIT-recognised start-ups with ≥ 1 woman director in 2024: 17,405
- 7. FY 2024-25 combined Index of Eight Core Industries growth: 4.4 %; its weight in IIP: 40.27 %.
- 8. Net direct-tax collection FY 25: ₹ 22.26 lakh crore (growth 13.57%); record refunds ₹ 4.76 lakh crore.
- RBI gold operations FY 25: 57.5 t purchased; total stock 879.6 t (global rank 8) = 11.4 % of FX reserves.
- 10. Repo rate cut to 6 % (-25 bps, April 2025) to spur demand.
- 11. United States stayed India's largest trading partner for the 4 th year (bilateral trade US \$ 131.84 bn, FY 25).
- 12. UN DESA World Social Report 2025 60 % of world population faces economic insecurity; framework: "People-Centric Social Development."
- 13. World Bank Poverty & Equity Brief 2024: India's extreme-poverty headcount fell from 16.2 % → 2.3 % (2011-12 → 2022-23), lifting 171 mm people; under US \$ 3.65/day line, 378 mm moved out of poverty.
