



- 33. The **Financial Intelligence Unit-India (FIU-IND)** imposed a penalty of **₹9.27 crore** on Bybit Fintech Limited (FIU-IND HQ: New Delhi; Director: Vivek Aggarwal; Bybit HQ: London, UK).

- 34. **HDFC Bank's "Anmol Savings Account"** (already noted in item 22) is India's first salary account offering cyber fraud protection.
- 35. **NPCI** will reject all UPI transactions if their transaction IDs contain special characters (e.g., @, !, #).

B. Regulatory, Market & Sector Initiatives

- 36. The RBI's **Monetary Policy Committee** (MPC) **2025** (7th February 2025) set rates as follows: Repo Rate at 6.25% (a 25-basis-point cut), Standing Deposit Facility (SDF) Rate at 6.00%, and Marginal Standing Facility (MSF) & Bank Rate at 6.50%; it also projected GDP growth of 6.4% in FY 2024-25 and 6.7% in FY 2025-26, with inflation projections of 4.8% (FY 2024-25) and 4.2% (FY 2025-26).
- 37. **Bharat Heavy Electricals Limited (BHEL)** received an ₹8,000 crore order from Maharashtra State Power Generation Company Limited (Mahagenco).
- 38. NHAI (National Highways Infrastructure Trust) plans to raise ₹20,000 crore from domestic and foreign investors.
- 39. The government approved ₹6,000 crore as additional funding for BSNL's 4G expansion.
- 40. **SEBI** is revamping **Business Responsibility and Sustainability Reporting (BRSR) standards** to align with global ESG norms.
- 41. The RBI increased its bond purchase amount in **Open Market Operations (OMO)** to ₹40,000 **crore** (up from ₹20,000 crore), noting a current liquidity deficit of ₹1.33 lakh crore in the banking system.
- 42. Maaza (the mango drink by Coca-Cola) crossed \$1 billion in sales in 2024.
- 43. **RBI** announced the setup of a **9-member working group** (chaired by Executive Director Radha Shyam Ratho) to review trading and settlement timings across regulated markets.
- 44. The RBI announced its **Gold Holdings in 2024**: Total gold reserves increased to **876.18 tonnes** (valued at \$66.2 billion) from 803.58 tonnes (\$48.3 billion) in 2023; net gold purchase was +**72.6 tonnes**; India ranks 9th globally, with top five holders being the US (81,336 tonnes), Germany (3,352 tonnes), IMF (2,814 tonnes), Italy (2,452 tonnes), and France (2,437 tonnes).
- 45. **SEBI** introduced **MITRA** (Mutual Fund Investment Tracing and Retrieval Assistant) to help investors track and reclaim inactive or unclaimed mutual fund folios.
- 46. **TRAI** amended the Telecom Commercial Communications Customer Preference Regulations (TCCCPR), 2018.
- 47. **SEBI** launched an **Industry Standards Forum (ISF)** to define the minimum information that listed entities must share regarding related party transactions.

C. Union Budget 2025-26 & Economic Reforms

- 48. The **Union Budget 2025-26** announced a total expenditure of **Rs 50.65 lakh crore** (7.4% higher than the revised 2024-25 estimate), with receipts (other than borrowings) of **Rs 34.96 lakh crore** (an 11.1% increase), and capital expenditure of **Rs 11.21 lakh crore** (3.1% of GDP).
- 49. Economic targets in the budget include a nominal GDP growth of **10.1% in FY 2025-26**, a revenue deficit of **1.5% of GDP**, and a fiscal deficit of **4.4% of GDP** (down from 4.8%).
- 50. The Centre aims to reduce outstanding liabilities to around 50% of GDP by March 2031 (estimated to be 56.1% in FY 2025-26).
- 51. The budget provides **Rs 1,50,000 crore** for special interest-free loans to states for capital expenditure.
- 52. Programs for women and children receive an allocation of **Rs 5,65,161 crore** in 2025-26 (an 18.5% increase over the revised 2024-25 estimate).
- 53. The FDI limit for the insurance sector is increased from **74% to 100%** for companies that invest their entire premium in India.
- 54. Highest allocation in the budget is for the Ministry of Defence at **Rs 6,81,210 crore** (13.4% of total expenditure), followed by Road Transport and Highways (**Rs 2,87,333 crore**), Railways (**Rs**

- **2,55,445 crore**), Ministry of Home Affairs (**Rs 2,33,211 crore**), and Ministry of Consumer Affairs, Food and Public Distribution (**Rs 2,15,767 crore**).
- 55. Notable changes include a **972% rise** in the Ministry of Corporate Affairs' allocation (from Rs 1,078 crore to Rs 11,561 crore) and a **61% budget cut** for the Ministry of Steel (from Rs 8,561 crore to Rs 3,362 crore); among scheme allocations, **MGNREGS** received the highest funding.
- 56. The **Union Budget 2025-26 "Sabka Vikas"** theme was presented by Finance Minister **Nirmala Sitharaman**, marking her 8th consecutive budget presentation (record overall: 10 times by Morarji Desai).
- 57. Union Budget 2025-26 details changes in TDS and TCS limits: Senior citizens will be exempt from TDS for interest income up to Rs 1 lakh (raised from Rs 50,000); rental income TDS exemption increases from Rs 2.4 lakh to Rs 6 lakh; under the Liberalised Remittance Scheme, the TCS threshold is raised from Rs 7 lakh to Rs 10 lakh.
- 58. Under the New Tax Regime (NTR), the **income tax rebate limit** is raised from **Rs 7 lakh to Rs 12 lakh**, with new tax slabs defined (0% tax for income up to Rs 4 lakh, 5% for Rs 4–8 lakh, 10% for Rs 8–12 lakh, 15% for Rs 12–16 lakh, 20% for Rs 16–20 lakh, 25% for Rs 20–24 lakh, and 30% for income above Rs 24 lakh).
- 59. The **Gender Budget** allocation increased to **8.86%** from 6.8% in FY 2024-25; **Rs 4.49 lakh crore** is allocated for the welfare of women and girls—a 37.25% increase over the previous Rs 3.27 lakh crore.
- 60. The Central Sector Scheme 'Skill India Programme' continues until 2026 with an overlay outlay of Rs 8,800 crore (covering 2022-23 to 2025-26).
- 61. The Union Cabinet approved an extension of the National Commission for Safai Karamcharis (NCSK) tenure until March 31, 2028.
- 62. In the Union Budget 2025-26, the limit for tax deduction on interest for senior citizens is proposed to increase from **Rs 50,000 to Rs 1 lakh**.
- 63. The budget sets up 50,000 Atal Tinkering Labs in Government schools over the next 5 years.
- 64. Union Finance Minister Nirmala Sitharaman announced an extension of the Jal Jeevan Mission (JJM) till 2028 with an outlay of Rs 67,000 crore.
- 65. The proposed Maritime Development Fund Corpus in the budget is Rs 25,000 crore.
- 66. As per National Statistics Office estimates, the projected real GDP growth rate in FY 2024-25 is **6.4%**.
- 67. As per the Union Budget 2025-26, a digital public infrastructure for international trade is proposed to be called **BharatTradeNet (BTN)**.
- 68. The National Institute of Food Technology, Entrepreneurship and Management is proposed to be established in Bihar.
- 69. The **Makhana Board** will be established in **Bihar** as per the Union Budget 2025-26.
- 70. The Government of India approved the introduction of the Mutual Credit Guarantee Scheme for MSMEs (MCGS-MSME), providing 60% guarantee coverage by NCGTC to Member Lending Institutions (MLIs).

D. Corporate, Investment & Infrastructure Announcements

- 71. **ONGC** set a capital expenditure (Capex) target of ₹36,920 crore for FY26.
- 72. **IHCL** will invest ₹2,500 crore to develop 'Taj Bandstand' in Mumbai.
- 73. **Adani Group** announced a partnership with US-based Mayo Clinic to launch **Adani Health City** (**AHC**) by building integrated healthcare campuses.
- 74. Reliance launched the 'Spinner' Sports Drink priced at ₹10.
- 75. **UDAN 5.5** is the new phase of the "Ude Desh ka Aam Naagrik" scheme for regional air connectivity.
- 76. **ONGC** is not to be confused with infrastructure targets see item 71.
- 77. Lam Research, a US-based semiconductor services company, will invest ₹10,000 crore in India.
- 78. GMR Airports Ltd joined the United Nations Global Compact (UNGC).

- 79. The **General Insurance Corporation of India (GIC Re)** approved the incorporation of its wholly owned subsidiary "GIC Re, India Service Company" in the United Kingdom.
- 80. Australia-based fintech firm **Findi** received RBI approval to acquire a 100% stake in **Tata Communications Payment Solutions Ltd** (**TCPSL**) via its Indian subsidiary Transaction Solutions International (TSI).
- 81. Sharan Hegde's financial edtech platform, The 1% Club, secured a Registered Investment Advisor (RIA) licence from SEBI.
- 82. Maaza (mango drink by Coca-Cola) crossed \$1 billion in sales in 2024.
- 83. **JioStar**, a joint venture between Viacom18 and Star India, launched the streaming platform "**JioHotstar**" (combining JioCinema and Disney+ Hotstar); **Kiran Mani** was appointed as CEO (Digital) of JioStar.
- 84. GIC Re's wholly owned subsidiary (see item 79) is part of corporate restructuring.
- 85. Australia-based fintech firm Findi's acquisition (see item 80) is included above.

E. Union Budget-Related Regulatory and Policy Announcements

- 86. Union Budget 2025-26 announces the "Gyan Bharatam Mission" for the survey, documentation, and conservation of India's manuscript heritage; allocation for the National Manuscripts Mission increased from ₹3.5 Cr to ₹60 Cr, with the overall Ministry of Culture allocation raised by about ₹100 Cr to ₹3,360.96 Cr (including allocations to ASI, National Libraries & Archives, and National Museum & National Gallery of Modern Art); note that NMM was set up in 2003.
- 87. (Duplicate of 86) As per Union Budget 2025-26, the initiative to preserve over one crore manuscripts is the **Gyan Bharatam Mission**.
- 88. Elon Musk's X and Visa collaborated on the "X Money Account" (with X headquartered in Texas, U.S. and CEO Linda Yaccarino).
- 89. The **Ministry of Finance** extended the moratorium for a special loan taken by the Ministry of Railways; total loan amount is ₹79,398 crore (with ₹63,000 crore as interest-free and ₹16,398 crore bearing interest), extended by 2 years up to FY 2025-26.
- 90. Union Budget 2025-26 "Sabka Vikas" and Economic Reforms were presented by Finance Minister Nirmala Sitharaman (her 8th consecutive budget, record overall: 10 times by Morarji Desai).

F. Energy, Infrastructure & Technology Developments

- 91. ONGC's Capex target (see item 71) is part of the energy infrastructure focus.
- 92. **India set a new target** of **500 GW** non-fossil fuel-based energy capacity by 2030 (previous target: 175 GW renewable energy capacity by 2022, including 100 GW solar power).
- 93. **Switch Mobility Ltd** (a subsidiary of Ashok Leyland and part of the Hinduja Group) unveiled the electric bus platform "**SWITCH EiV12**"—India's first low-floor city bus with chassis-mounted batteries; the Indian electric city bus market is projected to grow at a CAGR of 21% by 2030 with an EV penetration of 70%.
- 94. Shriram General Insurance (SGIC) introduced its first indemnity health insurance plan, "Shri Health Suraksha Insurance."

G. Taxation, Fiscal Measures & Budget Adjustments

- 95. The Union Budget 2025-26 includes changes in TDS and TCS limits (see item 57) and an increase in the income tax rebate limit under the New Tax Regime from Rs 7 lakh to Rs 12 lakh (with new tax slab details provided).
- 96. The revised **TDS/TCS thresholds** and tax rebate adjustments are part of a broader fiscal reform.
- 97. Union Budget 2025-26 targets a fiscal deficit of 4.4% of GDP (down from 4.8%).
- 98. Union Budget 2025-26 further specifies changes such as the exemption of senior citizens from TDS on interest income up to Rs 1 lakh.
