



### 1. G V Satish (NBCC Director) Sir's Top Picks

- 1. Celebrated cartoonist Harish Chandra Shukla, known by his pen name "Kaak", died →He is from Gaziabad, Uttar Pradesh
- 2. The Reserve Bank of India (RBI) formed a committee to examine the establishment of a Digital Payments Intelligence Platform (DPIP). The committee is chaired by A.P. Hota, the former managing director and chief executive officer (MD and CEO) of the National Payments Corporation of India (NPCI).
- **3.** The National Payments Corporation of India (NPCI) has increased the transaction limit for UPI 123Pay from ₹5,000 to ₹10,000, effective January 1, 2025.
- **4.** The Indian government has extended two crop insurance schemes—Pradhan Mantri Fasal Bima Yojana (PMFBY) and Restructured Weather Based Crop Insurance Scheme (RWBCIS)—until the 2025-26 period.
  - →Additionally, a fund of ₹824.77 crore has been created for technology infusion to enhance crop damage assessment and claim settlement processes.
- 5. The current rates are effective from January 1, 2025, to March 31, 2025.
  - → National Savings Certificate (NSC) : 7.7% per annum, compounded annually.
  - → Public Provident Fund (PPF): 7.1% per annum.
  - → Senior Citizen Savings Scheme (SCSS): 8.2% per annum.
  - → Kisan Vikas Patra (KVP): 7.5% per annum, with investments maturing in 115 months
- **6.** Key Features of NSC
  - $\rightarrow$  Interest Rate: 7.7% per annum, compounded annually. This rate has been consistent for the past four quarters.
  - → Maturity Period: 5 years from the date of investment.
  - → Minimum Investment: ₹1,000, with additional investments in multiples of ₹100. There is no maximum limit on investment.
  - $\rightarrow$  Tax Benefits: Investments qualify for a deduction under Section 80C of the Income Tax Act, up to a maximum limit of  $\ge 1.5$  lakh per financial year.
- 7. The Maha Kumbh Mela 2025 in Prayagraj, scheduled from January 13 to February 26
- **8.** GDP growth in the July-September 2024 quarter : 5.4%
- **9.** The Indian economy is expected to be a little weaker in 2025 according to IMF Managing Director Kristalina Georgieva

- → SISFS was initially established with a corpus of ₹945 crore to provide financial assistance to startups for various stages of development.

- **35.** A report by the Boston Consulting Group (BCG) indicates that India's trade is expected to grow by 6.4% annually, reaching USD 1.8 trillion by 2033.

#### 30. MFIN' Maximum 3 Lenders per Borrower" Rule

- → MFIN (Microfinance Institutions Network) is an organization that represents microfinance lenders in India.
- → To prevent over-borrowing, a single borrower (customer) cannot borrow from more than 3 different microfinance institutions
- → The deadline to fully follow this rule has been pushed back to April 1, 2025
- → A borrower cannot have more than ₹2 lakh in total microfinance loans outstanding. This means all microfinance loans combined should not exceed ₹2 lakh.
- → If a borrower already has a past-due amount greater than ₹3,000, lenders cannot give fresh loans until the overdue is cleared.
